These parents are given the last window of opportunity to present themselves at school and sign AOD between Monday, 18 November and Friday 22 November 2019. No other arrangements will be accepted beyond Friday 22 November 2019. Office Hours are from 08:00 - 15:30. **(NB – The school will not always do this arrangement, lest we experience non – attendance to meetings by parents)**

Tuesday, 03 December, The file for all Parents owing Schools fees, and those who will have defaulted the Fresh arrangement (AOD) will be handed over to our DEBT Collecting Company for processing of a **COURT CASE**.

The School has a sound relationship with All Parents. PPS Governing body and Management are of the strong view that the **COURT CASES** can be avoided.

All **PARENTS** are encouraged to **DO** the **RIGHT** thing - **PAY SCHOOL FEES**.

2. DECEMBER LEARNER REPORT CARDS

All parents whose school fees is settled, the Report Cards will be given to Learners. All parents Owing School Fees, Not Signed AOD, Signed AOD but did not pay as agreed should personally come and collect report Cards from the SGB at school.

All Parents who signed AOD, and paid as per agreement, Report Cards will be given to learners.

3. LOST / DAMAGED TEXTBOOKS & READERS

The school is retrieving all Textbooks issued to learner. All learners must return the textbooks in good condition.

Lost or Textbooks & Readers must be replaced at a cost of **R200.00**

4. Grade 7 Farewell - 22 – 23 November 2019

All learners whose School Fees is settled , Exempted from paying fees will participate provided that they pay a discounted amount of R500.00

5. Tablet Roll Out

PPS is going digital. Learners will still continue to write. Parents are encouraged to purchase Learner Tablets this year at R 2000.00. In 2020, The price will be increased to R2500.00.

NB: Tablets roll out benefits are subject to full programme implementation. For now, we have not yet implemented. Therefore, No Benefits are due to parents, learners and the school. This implies that even the second Tablet cannot be issued in January 2020 till we implement the programme which will generate income for the service provider and be able to procure all the benefits presented.

Full programme implementation simply means - All Learners at PPS owning a Tablet. We encourage parents to purchase Tablets in support of this Revolutionary Education. Let us Champion the future of an African child together.

6. Grade R & RR Space Available

7. Official School Re-opening for Grade R, RR and 1 Classes of 2020

Learners enrolled in the above classes will start school on the 14th Of January 2019.

Grade R and RR : 14/01/2020 at 10:00 - 11:30 - Arrival into School Hall for Orientation and break into classes

National Schools Official Re –opening: 15 January 2020. PPS starts at 07: 40. All learners must be Punctual.

8. Re-Registration of Learners - Grade 2 – 7 classes of 2020

The AGM has resolved that Parents should pay an amount of **R 2000.00** towards school fees on or before end of December 2019. Parents are reminded to implement this

resolution to avoid future challenges. This payment is part of school fees for Academic year 2020.

- **DISCOUNTS APPLICABLE ON SCHOOL FEES 2020 (R 7830.00)**
 - If fees for 2019 is settled and a tablet paid: school fees for 2020 SHALL BE : R 6030.00 for ten months. (January – October 2020)
 - If full school fees for 2020 is paid by end of January 2020 - 10% discount on the R 6030.00 school fees . Fees Payable will be : **R 5427.00**
 - If full school fees for 2020 is paid by end of February 2020 - 7.5% discount on the R 6030.00 school fees. Fees Payable will be : **R5577.80**
 - If full school fees for 2020 is paid by end of March 2020 - 5 % discount on the R 6030.00 school fees. Fees Payable will be : **R 5728.50**
 - NOT DISCOUNT APPLICABLE FROM APRIL ONWARDS
